We are therefore establishing a list of approved transportation companies which will be posted on our websites ([www.FreeRunCellars.com](http://www.FreeRunCellars.com), [www.RoundBarnWinery.com](http://www.RoundBarnWinery.com) and [www.TaborHill.com](http://www.TaborHill.com)) and recommend to fans who plan to bring such groups to our facilities. This will allow us to build a closer working relationship with such companies and allow us to better accommodate our guests.

Please take a moment to familiarize yourself with the following information and to register with us so that we may better serve our guests. Thank you for working with us.

### Moersch Hospitality Group has agreed to:

- Provide preference to those transportation companies who have agreed to and signed the Responsible Transportation Partner Agreement, in contrast to companies who have not.
- Provide promotion of the transportation company by adding the company name to our webpage as a preferred transportation partner.

### As a transportation Company, I agree to the following:

- I agree to make reservations or ask my guests to make reservations. Also agree to cancel or change group tastings up to 24 hours prior to reservation.
- Instituting a policy that prohibits the consumption of alcohol on your bus or limo is highly recommended. Our liquor license only allows for our products to be consumed on our property. No outside alcohol permitted. All alcohol must stay on the vehicle.
- I agree to encourage responsible enjoyment of alcohol consumption during a visit to a Moersch Hospitality Group facility.
- I agree to park in designated bus and limo parking areas.
- I agree on a best effort basis to ensure that the guest I bring to a Moersch Hospitality Group facility are neither intoxicated nor disruptive.
- I agree to take action to correct any customer related problem that is brought to my attention by Moersch Hospitality Group personnel, including removal from the premises.
- I agree to provide a copy of this agreement to all of my drivers.
